# 7. Non-Recurring Action Items

# a. Treasurer's Report thru 31 December 2021

- Net Income for 2021 is \$99,613
- Net income was due to some families paying more than their pledge
- Contributing income was higher than expected
- Only Clergy Discretionary Fund expenditure was in June 2021 for \$300.
- Venmo donations for Christmas flowers, loan repayment, pledge, donations
- In 2022, the treasurer will withdraw \$15,952 from TDAmeritrade going to maintenance
- In 2022, the treasurer will withdraw

# b. 2022 Budget - Treasurer - Neal Matsunaga

#### INCOME

- Drop in pledges for 2022 from \$630,706 (actual received) to \$576,455 (pledged). The budgeted pledge income for 2021 was \$615,674. The drop in the 2022 pledge vs the 2021 received is \$39,219.
- Projected total income is \$663,293.

#### **EXPENSES**

- Staff Compensation increase 3.2% per recommendation from the Diocese
- Diocesan assessment goes up \$1000 from 2021 the assessment is based on the church budget 2 years ago

- Ministry budget changes
  - Altar Guild \$500 less than budgeted for 2021
  - Music \$200 less than budgeted for 2021
  - Christian Formation \$500 less than budgeted for 2021
  - Children & Youth \$900 more than budgeted for 2021
  - Worship & Liturgy same as budgeted for 2021
  - Pastoral Care same as budgeted for 2021
  - Fellowship \$600 more than budgeted for 2021
  - Administration \$8000 less than budgeted for 2021 no more postage meter and a new copier lease account for most of the reduction
  - Facilities less than \$300 change from 2021 budget
  - Finance \$14,000 increase due to issue with sewer tax which is being negotiated
  - Outreach same as 2021
  - o Contingency \$10,000 vs \$5000 in 2021
- Projected shortage is \$126,882
- Carleen and Neal do not expect a lot more pledges
- Church Property Tax bill went from \$7,138 to \$18,118 due to sewer charge based on water usage. Neal has negotiated the reduction but the Diocese has not paid the bill. Probable reduction of \$10,000
- We have reserves that could cover the shortfall for 1 year and maybe 2 years.
- Neal met with Dick, Linda & XXX regarding problem
- Last time, staff cuts and Outreach cuts reduced the deficit
- Finance and Neal recommend parish town-hall meetings about the problem after the Annual Meeting

## Linda

- In the past, the budget has been modified during the year
- \$70,000 if the reduction in pledge income is due to people moving or passing away.
- About \$35,000 is due to pledge reductions

#### Neal

Some non-pledgers are unhappy with the church

# Discussion

- Pastor Susan has not been asked to talk to anyone about pledging
- Pastor Susan: Parish Members who don't pledge again expect to be contacted and asked why.

- Pastor Susan: Asked that Neal include a mention of the parish generosity re Outreach and Live Stream
- Ade: Need to look at the expenses
- Neal & Dick: Expenses reductions unless they are staff cuts won't give us the needed money
- Neal: problem income is not keeping up with expenses due to flat pledges and membership not growing
- Jacque: Telling the parish that losing Pastor Susan might be a consequence of cuts to balance the budget will make an impact on the parish
- Trudy: Need to make the parish look at what the church means to them. We are a family and need to pull together to address the problem
- Pastor Susan: St Timothy's members need to value the community and reflect it in pledging and legacy gifts
- Neal: about 50% of our pledgers give the same amount from year to year; a small number increase; a small number decrease
- Linda: problem is partly due to a large number of retired people on a fixed income
   MOTION: Approve the budget as presented passed unanimously
