# **RECTOR'S ARTICLE**

Happy New Year all,

I am really looking forward to a new year with you. I know the vaccine will take time to roll out, but I am almost giddy thinking about seeing you in person. Here is the regathering vision (it might change) but is my best hope right now:

**Regathering best case scenario** - our first on-campus worship might be in April 2021. This date is not accidental or random. Our first on campus Sunday (best-case) will occur when we are in the covid "yellow tier" for at least two weeks in Contra Costa County. The St. Timothy's Episcopal Church Annual Meeting is scheduled for Sunday, January 31, 2021 after the 10:00 service. The current prediction is that this year's meeting will be virtual using Zoom or YouTube or something similar. Normally at the annual meeting parish members receive the annual report. This year, we plan to distribute that report as a PDF file and mail a paper copy to parish members who request it. The plan is to finalize the report on Monday, January 25 and post the PDF file to the St. Timothy's website on Tuesday, January 26th. Once the report is posted, parish members will get an email with a link to the file on the website so they can read it there or download it. The last annual report was 3.8 oz which will cost about \$1.45 to mail.

Drive into the parking lot, pop your trunk & we will do the rest. We are following good Covid protocols. Lenten Writers Needed!



# St Timothy's Episcopal Church Vestry Meeting Highlights - December 2020

The vestry met on Wednesday, December 16, at 6:30 pm via Zoom

### **MOTIONS:**

- **Budget:** The vestry approved the draft 2021 budget submitted by the treasurer and reviewed by the Finance Committee. The balance is balanced but only because of the excess income due to the PPP loan and a draw on the pledge reserve, reductions in several program areas and a reduction in the bookkeeper hours. The 2021 budget may be modified in January 2021 based on changes to anticipated pledge and other income.
- Excess 2020 Income allocation: The vestry approved the proposal to add the excess income from 2020 to the 2021 income and the maintenance reserve.
- **Funds for the sanctuary TV's:** The vestry approved reimbursing the Memorial Funds used to purchase the large new TV's from the funds for the Live Stream.
- Clergy 2021 Housing Resolutions: The vestry approved the clergy 2021 Housing allowance needed for the IRS.
- Audit of the church books: The vestry approved the proposal by the treasurer and the diocesan auditor to audit the 2019 and 2020 church books and skip auditing the 2018 books.
- The vestry approved the proposal to **remove the vestry clerk and treasurer as voting members** of the vestry. If either is an elected member of the vestry, they do vote and are counted toward a quorum.
- The **minutes** of the November Vestry meeting, the treasurer's report and the submitted rector and commission **reports** were approved a proposed.

### **OTHER NEWS:**

- 2021 vestry: Four people have agreed to stand for the 2021 vestry. There are 2 more available slots.
- **Vestry calling:** The clergy will be calling parish members to wish them happy holidays and the vestry will make parish calls during the Christmas season.

Parish members are welcome to attend Vestry meetings. The next meeting is on Wednesday, January 20, 2021. Contact Sally Shea Potts for an invitation to the Zoom meeting.

The minutes of the vestry meeting will be filed in the Parish Office after they are approved by the Vestry.

## **Financial Highlights**

- Financial results through November are positive overall due to inclusion of PPP loan funds in the Other Income part of the operating budget. There is an underrun in Pledge Income due mainly to pledges that are behind in payments and an underrun in Expenses reflecting a decrease in expenses due to shelter in place protocols.
- Pledge income in our approved budget for 2020 is based on 159 pledges. Our budget included a
  projected revenue shortfall of about \$58,400 (\$13,400 more pledge dollars assumed and a projected deficit
  of \$45,034.
- 4 pledges for \$12,600 have not made any payments yet in 2020.
- 67 pledges are paid in full for \$278,213.
- Year to date budget vs actual results, adjusted for amortizing "pledges paid in full" in the current year, are:

### Income

The Pledge Income underrun reflects about \$19,342 for pledges that have not made any payments yet through the first 11 months of 2020 and about \$11,550 included in pledge income budget on the assumption that we would receive additional pledges during the year.

Other Income difference due to:

Loose Plate \$(7,780) and Facilities Cost Sharing \$(10,948) under budget offset by Contributing Income about \$15,286 above budget and inclusion of \$73,329 of PPP loan funds as operating income.

Expenses – Operating expense difference is the sum of a number of over and under budget items, with the main ones being:

Personnel expenses \$23,199 under budget

Altar Guild expenses \$3,094 under budget

Christian Formation expenses \$1,113 under budget

Children & Youth Ministry expenses \$3,169 under budget

Fellowship expenses \$3,310 under budget

Administrative expenses \$9,841 under budget

Facilities expenses \$(7,937) over budget

Finance expenses \$(11,895) over budget due to timing of insurance and property tax payments.

Contingency expenses \$3,464 under budget
