
EDUCATION FOR MINISTRIES 2020 - 2021

In the opening pages, Henry Lee comes upon a crowd gathered outside the Panama Hotel, once the gateway to Seattle's Japantown. It has been boarded up for decades, but now the new owner has made an incredible discovery: the belongings of Japanese families, left when they were rounded up and sent to internment camps during World War II. This takes Henry back to the 1940s, at the height of the war, when young Henry's world is a jumble of confusion and excitement, and to his father, who is obsessed with the war in China and having Henry grow up American. While "scholarshipping" at the exclusive Rainier Elementary, where the white kids ignore him, Henry meets Keiko



Okabe, a young Japanese American student. Amid the chaos of blackouts, curfews, and FBI raids, Henry and Keiko forge a bond of friendship—and innocent love—that transcends the long-standing prejudices of their Old World ancestors. And after Keiko and her family are swept up in the evacuations to the internment camps, she and Henry are left only with the hope that the war will end, and that their promise to each other will be kept.

Forty years later, in the hotel's dark dusty basement Henry begins looking for signs of the Okabe family's belongings. Now a widower, Henry is still trying to find his voice—words that might bridge the gap between him and his modern, Chinese American son; words that might help him confront the choices he made many years ago. Set during one of the most conflicted and volatile times in American history, *Hotel on the Corner of Bitter and Sweet* is an extraordinary story of commitment and enduring hope. In Henry and Keiko, Jamie Ford has created an unforgettable duo whose story teaches us of the power of forgiveness and the human heart.

OPTIONS RECOVERY SERVICES UPDATE

Update on Options Recovery Services, an Outreach Supported Ministry

During the Covid pandemic, Options has remained committed to the people and communities we serve by providing high quality substance use disorder outpatient, intensive outpatient, testing, and housing services.

Dr. David Coady founded Options on the premise that people and their families who suffer from substance use disorders who need our help are never turned away or forgotten, that our doors are always open, and that people must get the help that they need, when they need it most. The pandemic does not separate us from these values. In response to the virus, Options:

- transitioned to telehealth services, providing video and audio conferencing at both individual and group levels by skilled counselors and clinicians
- remained open for new referrals and intake of new clients, including clients released from prisons and from other organizations forced to curtain or limit their own services
- implemented preventative and precautionary measures including health screening at intake and at all residences and clinical settings
- continued to provide treatment, drug testing, and recovery residence services throughout northers Alameda County.

Options residents sheltered in place, receiving telehealth services and direct support at the houses. Options clients who screened as potentially virus infected were quarantined and referred for medical treatment when necessary. Through strict protocols and preventative efforts, the virus has been kept largely at bay.

Over the past year Options has begun offering addiction recovery services in Alameda County's Santa Rita Jail, and has expanded its reception center programming to three California prisons. Due to the success of Options inprison services, Options has been contracted by the California Department of Corrections and Rehabilitation to expand its Offender Mentor Certification Program to seven prisons through the state. And the California Board of State and Community Corrections has awarded Options funds to serve reentry clients as they return to society from prison.

The California Arts Council funds Options Reentry Through the Arts program. Options client Samuel M. rediscovered his own art through the program, creating a graphic arts calendar to illustrate the 12 steps of his recovery. Samuel graduated from Options, became our intake coordinator, and teaches art classes for the clients. "The recovery journey can build on more than drugs and alcohol," he says, "but on finding a new way to live." Samuel is now enrolled at the California Institute of Integral Studies pursuing a master's degree in Arts Therapy.

Options takes this opportunity to thank St. Timothy's for your continuing support, and to invite you to join with us in celebrating nationally recognized Recovery Month this September by participating the these events:

September 4: Options Graduation Celebration - During the pandemic, Options has implemented a Zoom-based graduation ceremony, broadcast live on Facebook and on Options' website (www.optionsrecovery.org). St. Timothy's Church is the official sponsor of the event, and is recognized in the proceedings. Options graduates tell their moving stories of transformation as they have pursued their sobriety and remained free of drugs and alcohol for over one full year!

THE GRETA FOUNDATION UPDATE



In collaboration with the Africa Action Network, The Gretta Foundation will be purchasing close to 4,000 face masks for distribution to nursing and midwife personnel at United Catholic Medical Bureau in Kampala, Uganda. UCMB provides nursing and midwife education to Gretta Foundation scholars in Uganda.

The masks are currently being produced by KIU Nurses and Midwives Student Association and should be delivered within the next couple weeks. This also provides a much needed source of income for students.

There were a couple bumps in the road, but due to great cooperation and communication we were able to get things done. These are in addition to masks sent earlier this year.

VESTRY MEETING HIGHLIGHTS

St Timothy's Episcopal Church Vestry Meeting Highlights -August 2020

The vestry met in via Zoom on Wednesday, August 19th and Tuesday, August 25th

MOTIONS:

MOTION: Vestry approved changing the current <u>church insurance</u> to enable coverage of the new live-stream equipment under our current property and liability policy. Passed unanimously.

MOTION: The vestry accepts the proposed gift by an anonymous donor of approximately \$65,400 to continue the renovations of the parish hall. Passed unanimously.

MOTION: The vestry Approved the minutes of the vestry meetings in June, July and early August, the treasurer's report and documents and the reports submitted by the Rector, Worship Commission and the Property Commission.

MOTION: Vestry voted to approve the <u>new contract with Comcast</u> for improved Internet service (faster) and new phones for Grace House. Included in the motion was the allocation of \$3,326.40 from the donated Live-Stream funds to pay for the increased Comcast Internet & phones contract cost for the new 2 years.

OTHER INFORMATION

Vestry members will be calling parish members over the next month to find out how they are doing.

As of Thursday, August 27th, the <u>FOTH-2020 Reimagined Outreach campaign</u> has raised \$51,300 for donation to the charities we work with. The FOTH-2020 Reimagined campaign runs through August 31. The Outreach Committee will meet this fall to propose allocation of the funds which will then be reviewed by the Vestry.

Currently Contra Costa County plans to use the St. Timothy's parish hall as a voting site.

Food Drives for Monument Crisis Center are scheduled for Sundays, September 6 and September 20.

Parish members are welcome to attend Vestry meetings. The next meeting is on Wednesday, September 16, 2020. Contact Sally Shea Potts for an invitation to the Zoom meeting.

TREASURER'S REPORT

August 19, 2020

Financial Highlights

- Financial results through July are positive overall though slightly negative in terms of income. There is an underrun in Pledge Income due mainly to pledges that have not made any payments to date and an underrun in Expenses reflecting a decrease in expenses due to shelter in place rules.
- Pledge income in our approved budget for 2020 is based on 159 pledges and includes an assumption that
 at least 6 additional pledges for at least \$13,400 will be received. As of the end of July, 3 additional
 pledges for \$1,980 have been received. Our budget included a revenue shortfall of about \$58,400
 (\$13,400 more pledge dollars assumed and a projected deficit of \$45,034). The hope was that additional
 new pledges would be received during this year, as in 2019, to help close the deficit.
- 12 pledges for \$40,000 have not made any payments yet in 2020. Last month this number was 13 pledges for \$40,200.
- 30 pledges are paid in full for \$135,751. Last month it was 28 for \$133,051.
- Year to date budget vs actual results, adjusted for amortizing "pledges paid in full" in the current year, are:

The Pledge Income difference reflects about \$23,333 for pledges that have not made any payments yet through the first 7 months of 2020. Had this money been received our pledge income would have been about \$2,569 under budget through July.

Other Income difference due to:

Loose Plate \$(4,180) and Facilities Cost Sharing \$(2,935) under budget offset by Contributing Income about \$7,440 above budget due primarily to two large gifts several months ago.

Expenses – Operating expense difference is the sum of several over and under budget items, with the main ones being:

Personnel expenses \$15,391 under budget

Altar Guild expenses \$1,549 under budget

Children & Youth Ministry expenses \$2,016 under budget.

Fellowship expenses \$1,910 under budget.

Administrative expenses \$4,519 under budget.

Facilities expenses \$11,179 under budget due to campus and rectory maintenance being under budget offset by utilities being over budget. Utilities over budget was due to an extended, undetected leak in the water pipe to Grace House \$(832).

Finance expenses \$786 under budget due to timing of stewardship expenses \$(1,400) and timing of payment for campus property taxes \$(5017) offset by timing of payment of property & liability insurance premiums \$5,017.

Contingency expenses \$2,572 under budget.
